

House Bill 755 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to
2 elementary and secondary education generally, so as to provide that each local board of
3 education shall provide its local charter schools with preliminary allotment sheets for the
4 upcoming fiscal year within 45 calendar days of receiving its preliminary allotment sheet
5 from the Department of Education; to provide that each local board of education shall publish
6 in a prominent location on its website the calculation of earnings to each local charter school;
7 to provide that when a local board of education determines that an adjustment to the
8 allocation for a local charter school is necessary, the local board of education shall provide
9 the local charter school with 30 days' notice before the allocation is adjusted, provide an
10 amended itemized allotment sheet to the local charter school, and publish the amended
11 itemized allotment sheet in a prominent location on its website; to require local school
12 systems to post required information regarding intradistrict transfers, including relevant dates
13 and deadlines, in a prominent location on its website; to provide for related matters; to repeal
14 conflicting laws; and for other purposes.

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

16 style="text-align:center">**SECTION 1.**

17 Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to elementary and
18 secondary education generally, is amended in Code Section 20-2-2068.1, relating to charter
19 school funding, by revising subsection (c.3) as follows:

20 "(c.3)(1) Each local board of education that has one or more local charter schools shall
21 provide each local charter school with a preliminary annual allotment sheet itemizing the
22 preliminary calculation of state, local, and federal allocations to be provided by the local
23 school system to the local charter school for the upcoming fiscal year not later than 45
24 calendar days after the local school system receives its preliminary annual allotment sheet
25 from the Department of Education.

26 (2) The local board of education shall publish in a prominent location on its website the
 27 calculation of earnings to each local charter school made pursuant to subsections (a), (b),
 28 and (c) of this Code section, including federal funds received by each local charter
 29 school. Such calculations shall be published as soon as practicable prior to the
 30 distribution of funds to the local charter school by the local board, and no later than
 31 October 1 of each year, and shall be updated upon receipt of any additional federal funds
 32 received pursuant to state reallocation of federal funds and distributed to local charter
 33 schools. Such calculations may be published in conjunction with the financial and
 34 transparency information required to be published by local boards of education pursuant
 35 to ~~Part 3A~~ Part 3B of Article 2 of Chapter 14 of Title 20. In the event that the
 36 Department of Education makes such calculations available on its website, a local board
 37 of education may post a link in a prominent location on its website to the Department of
 38 Education's web page which contains such calculations to comply with this subsection.
 39 (3) In the event that the local board of education determines that an adjustment to the
 40 allocation for a local charter school is necessary, the local board of education shall
 41 provide the local charter school with 30 days' notice before the allocation is adjusted,
 42 shall provide an amended itemized allotment sheet to the local charter school, and shall
 43 publish the amended itemized allotment sheet in a prominent location on its website."

44 **SECTION 2.**

45 Said chapter is further amended in Code Section 20-2-2131, relating to enrollment of
 46 students in school to which not originally assigned, procedure, annual notification, and
 47 exception, by revising subsection (c) as follows:

48 "(c) Each local school system shall annually notify prior to each school year the parents
 49 of each student by letter, electronic means, or by such other reasonable means in a timely
 50 manner of the options available to ~~the parent~~ parents under this article, including all
 51 relevant dates and deadlines. As a part of such annual notification process, each local
 52 school system shall post in a prominent location on its website the information required
 53 pursuant to this Code section."

54 **SECTION 3.**

55 All laws and parts of laws in conflict with this Act are repealed.
