

House Bill 1007 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating the Board of Commissioners of Crawford County, approved
2 March 2, 1874 (Ga. L. 1874, p. 339), as amended, particularly by an Act approved
3 March 5, 2012 (Ga. L. 2012, p. 4012), so as to revise districts for the election of members
4 of the board of commissioners; to provide for definitions and inclusions; to provide for
5 continuation in office of current members; to provide for election and terms of office of
6 subsequent members; to provide for related matters; to provide for effective dates; to repeal
7 conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Crawford County, approved March 2, 1874
11 (Ga. L. 1874, p. 339), as amended, particularly by an Act approved March 5, 2012
12 (Ga. L. 2012, p. 4012), is amended by revising Section 3 as follows:

13 "SECTION 3.

14 (a)(1) Those members of the Board of Commissioners of Crawford County who are
15 serving as such on the effective date of this Act and any person selected to fill a vacancy

16 in any such office shall continue to serve as such members until the regular expiration of
17 their respective terms of office and upon the election and qualification of their respective
18 successors.

19 (2) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the
20 effective date of this Act, shall continue to be designated as Commissioner Districts
21 1, 2, 3, 4, and 5, respectively, but as newly described under this Act, and on and after the
22 effective date of this Act, such members of the board serving from those former
23 commissioner districts shall be deemed to be serving from and representing their
24 respective districts as newly described under this Act.

25 (b) For the purpose of electing members of the board of commissioners, Crawford County
26 shall be divided into five commissioner districts. Commissioner Districts 1, 2, 3, 4, and 5
27 shall be and correspond to those five numbered districts described in Appendix A attached
28 to and made a part of this Act and further identified as 'User: Crawford Co. Plan Name:
29 CrawfordCCSB-2022 Plan Type: Local'.

30 (c)(1) For the purposes of such plan:

31 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
32 provided in the report of the Bureau of the Census for the United States decennial
33 census of 2020 for the State of Georgia. The separate numeric designations in a district
34 description which are underneath a VTD heading shall mean and describe individual
35 Blocks within a VTD as provided in the report of the Bureau of the Census for the
36 United States decennial census of 2020 for the State of Georgia; and

37 (B) Except as otherwise provided in the description of any district, whenever the
38 description of any district refers to a named city, it shall mean the geographical
39 boundaries of that city as shown on the census maps for the United States decennial
40 census of 2020 for the State of Georgia.

41 (2) Any part of Crawford County which is not included in any district described in
42 subsection (b) of this section shall be included within that district contiguous to such part

43 which contains the least population according to the United States decennial census of
44 2020 for the State of Georgia.

45 (3) Any part of Crawford County which is described in subsection (b) of this section as
46 being included in a particular district shall nevertheless not be included within such
47 district if such part is not contiguous to such district. Such noncontiguous part shall
48 instead be included within that district contiguous to such part which contains the least
49 population according to the United States decennial census of 2020 for the State of
50 Georgia."

51 **SECTION 2.**

52 Said Act is further amended by striking and reserving subsection (c) of Section 3B.

53 **SECTION 3.**

54 The provisions of this Act necessary for the election of members of the Board of
55 Commissioners of Crawford County in 2022 shall become effective upon the approval of this
56 Act by the Governor or upon its becoming law without such approval. The remaining
57 provisions of this Act shall become effective January 1, 2023.

58 **SECTION 4.**

59 All laws and parts of laws in conflict with this Act are repealed.
