

House Bill 1024 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act establishing the Board of Commissioners of Talbot County, approved
2 February 16, 1876 (Ga. L. 1876, p. 291), as amended, particularly by an Act approved March
3 13, 2012 (Ga. L. 2012, p. 4305), so as to change the description of the commissioner
4 districts; to provide for definitions and inclusions; to provide for continuation in office of
5 current members; to provide for effective dates; to repeal conflicting laws; and for other
6 purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act establishing the Board of Commissioners of Talbot County, approved February 16,
10 1876 (Ga. L. 1876, p. 291), as amended, particularly by an Act approved March 13, 2012
11 (Ga. L. 2012, p. 4305), is amended by revising paragraphs (1), (2), and (3) of subsection (b)
12 of Section 1 as follows:

13 "(b)(1) For purposes of electing members of the board of commissioners, Talbot County
14 shall be divided into five commissioner districts. Commissioner districts 1, 2, 3, 4, and
15 5 shall be and correspond to those five numbered districts described in Appendix A

16 attached to and made a part of this Act and further identified as 'User: Talbot Co. Plan
17 Name: TalbotCCSB-2022 Plan Type: Local'.

18 (2)(A) For the purposes of such plan:

19 (i) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a
22 district description which are underneath a VTD heading shall mean and describe
23 individual Blocks within a VTD as provided in the report of the Bureau of the Census
24 for the United States decennial census of 2020 for the State of Georgia; and

25 (ii) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (B) Any part of Talbot County which is not included in any district described in
30 paragraph (1) of this subsection shall be included within that district contiguous to such
31 part which contains the least population according to the United States decennial census
32 of 2020 for the State of Georgia.

33 (C) Any part of Talbot County which is described in paragraph (1) of this subsection
34 as being included in a particular district shall nevertheless not be included within such
35 district if such part is not contiguous to such district. Such noncontiguous part shall
36 instead be included within that district contiguous to such part which contains the least
37 population according to the United States decennial census of 2020 for the State of
38 Georgia.

39 (3) Those members of the Board of Commissioners of Talbot County who are serving
40 as such on the effective date of this Act and any person selected to fill a vacancy in any
41 such office shall continue to serve as such members until the regular expiration of their
42 respective terms of office and upon the election and qualification of their respective

43 successors. Commissioner districts 1, 2, 3, 4, and 5, as they exist immediately prior to
44 the effective date of this Act, shall continue to be designated as commissioner districts
45 1, 2, 3, 4, and 5, respectively, but as newly described under this Act, and on and after the
46 effective date of this Act, such members of the board serving from those former
47 commissioner districts shall be deemed to be serving from and representing their
48 respective districts as newly described under this Act."

49 **SECTION 2.**

50 The provisions of this Act necessary to conduct elections for the members of the Board of
51 Commissioners of Talbot County in 2022 shall become effective upon the approval of this
52 Act by the Governor or upon its becoming law without such approval. The remaining
53 provisions of this Act shall become effective on January 1, 2023.

54 **SECTION 3.**

55 All laws and parts of laws in conflict with this Act are repealed.
