

House Bill 1072 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating the Board of Commissioners of McIntosh County, approved
2 February 26, 1876 (Ga. L. 1876, p. 283), as amended, particularly by an Act approved
3 February 27, 2012 (Ga. L. 2012, p. 3653) and by an Act approved March 3, 2014
4 (Ga. L. 2014, p. 4249), so as to change the description of the commissioner districts; to
5 define certain terms and provide for certain inclusions; to provide for continuation in office
6 of current members; to provide for related matters; to provide effective dates; to repeal
7 conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of McIntosh County, approved
11 February 26, 1876 (Ga. L. 1876, p. 283), as amended, particularly by an Act approved
12 February 27, 2012 (Ga. L. 2012, p. 3653) and by an Act approved March 3, 2014
13 (Ga. L. 2014, p. 4249), is amended by revising Section 1 as follows:

"SECTION 1.

14

15 (a) For the purpose of electing members of the board of commissioners, McIntosh County
16 shall be divided into five commissioner districts. Commissioner Districts 1, 2, 3, and 4 shall
17 be and correspond to those four numbered districts described in Appendix A attached to and
18 made a part of this Act and further identified as 'User: McIntosh Co. Plan Name:
19 McIntoshCCSB-2022 Plan Type: Local'. Commissioner District 5 shall be comprised of the
20 entire geographic area of McIntosh County.

21 (b)(1) For the purposes of such plan:

22 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
23 provided in the report of the Bureau of the Census for the United States decennial
24 census of 2020 for the State of Georgia. The separate numeric designations in a district
25 description which are underneath a VTD heading shall mean and describe individual
26 Blocks within a VTD as provided in the report of the Bureau of the Census for the
27 United States decennial census of 2020 for the State of Georgia; and

28 (B) Except as otherwise provided in the description of any district, whenever the
29 description of any district refers to a named city, it shall mean the geographical
30 boundaries of that city as shown on the census maps for the United States decennial
31 census of 2020 for the State of Georgia.

32 (2) Any part of McIntosh County which is not included in any district described in
33 subsection (a) of this section shall be included within that district contiguous to such part
34 which contains the least population according to the United States decennial census
35 of 2020 for the State of Georgia.

36 (3) Any part of McIntosh County which is described in subsection (a) of this section as
37 being included in a particular district shall nevertheless not be included within such
38 district if such part is not contiguous to such district. Such noncontiguous part shall
39 instead be included within that district contiguous to such part which contains the least

40 population according to the United States decennial census of 2020 for the State of
41 Georgia.”

42 **SECTION 2.**

43 (a) Those members of the Board of Commissioners of McIntosh County who are serving as
44 such on the effective date of this Act and any person selected to fill a vacancy in any such
45 office shall continue to serve as such members until the regular expiration of their respective
46 terms of office and upon the election and qualification of their respective successors.

47 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
48 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
49 respectively, but as newly described under this Act, and on and after the effective date of this
50 Act, such members of the board serving from those former commissioner districts shall be
51 deemed to be serving from and representing their respective districts as newly described
52 under this Act.

53 **SECTION 3.**

54 The provisions of this Act necessary to conduct elections for the members of the Board of
55 Commissioners of McIntosh County in 2022 shall become effective upon the approval of this
56 Act by the Governor or upon its becoming law without such approval. The remaining
57 provisions of this Act shall become effective on January 1, 2023.

58 **SECTION 4.**

59 All laws and parts of laws in conflict with this Act are repealed.
