

House Bill 1163 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the election of members of the Board of Education of Dodge  
2 County, approved March 6, 1996 (Ga. L. 1996, p. 3507), as amended, particularly by an Act  
3 approved February 27, 2012 (Ga. L. 2012, p. 3773), so as to change the description of the  
4 education districts; to provide for definitions and inclusions; to provide for the continuation  
5 in office of the current members; to provide for effective dates; to provide for related matters;  
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the election of members of the Board of Education of Dodge County,  
10 approved March 6, 1996 (Ga. L. 1996, p. 3507), as amended, particularly by an Act approved  
11 February 27, 2012 (Ga. L. 2012, p. 3773), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) For purposes of electing members of the board of education of Dodge County, the  
14 Dodge County School District is divided into seven education districts. The seven  
15 education districts shall be and correspond to those seven numbered districts described in

16 Appendix A attached to and made a part of this Act and further identified as 'User: Dodge  
17 Plan Name: DodgeSB-2002 Plan Type: Local SB'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2020 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a VTD heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2020 for the State of Georgia.

29 (2) Any part of the Dodge County School District which is not included in any district  
30 described in subsection (a) of this section shall be included within that district contiguous  
31 to such part which contains the least population according to the United States decennial  
32 census of 2020 for the State of Georgia.

33 (3) Any part of the Dodge County School District which is described in subsection (a)  
34 of this section as being included in a particular district shall nevertheless not be included  
35 within such district if such part is not contiguous to such district. Such noncontiguous  
36 part shall instead be included within that district contiguous to such part which contains  
37 the least population according to the United States decennial census of 2020 for the State  
38 of Georgia."

39 **SECTION 2.**

40 (a) Those members of the Board of Education of Dodge County who are serving as such  
41 immediately prior to the effective date of this Act, and any person selected to fill a vacancy

42 in any such office, shall continue to serve as such members until the regular expiration of  
43 their respective terms of office and upon the election and qualification of their respective  
44 successors.

45 (b) Education Districts 1 through 7, as they exist immediately prior to the effective date of  
46 this Act, shall continue to be designated as Education Districts 1 through 7, respectively, but  
47 as newly described under this Act, and on and after the effective date of this Act, such  
48 members of the board serving from those former education districts shall be deemed to be  
49 serving from and representing their respective districts as newly described under this Act.

50 **SECTION 3.**

51 The provisions of this Act necessary to conduct elections for the members of the Board of  
52 Education of Dodge County in 2022 shall become effective upon the approval of this Act by  
53 the Governor or upon its becoming law without such approval. The remaining provisions  
54 of this Act shall become effective on January 1, 2023.

55 **SECTION 4.**

56 All laws and parts of laws in conflict with this Act are repealed.
