

House Bill 1171 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to reconstitute the Board of Education of Monroe County, Georgia,
2 approved February 25, 1993 (Ga. L. 1993, p. 3857), as amended, so as to change the
3 description of the education districts; to provide for definitions and inclusions; to provide for
4 the continuance in office of current members; to provide for related matters; to provide
5 effective dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act to reconstitute the Board of Education of Monroe County, Georgia, approved
9 February 25, 1993 (Ga. L. 1993, p. 3857), as amended, is amended by revising subsections
10 (b) and (c) of Section 2 to read as follows:

11 "(b) For purposes of electing a Board of Education of Monroe County, the Monroe County
12 School District shall be divided into seven education districts as provided in this
13 subsection. One member of the board shall be elected from each such district by the voters
14 voting only in such district. The seven education districts shall be and correspond to those
15 seven numbered districts described in Appendix A attached to and made a part of this Act
16 and further identified as 'User: Monroe SB Plan Name: MonroeSB-2022 Plan Type: Local.

17 (c) For the purposes of such plan:

18 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
19 provided in the report of the Bureau of the Census for the United States decennial census
20 of 2020 for the State of Georgia. The separate numeric designations in a district
21 description which are underneath a VTD heading shall mean and describe individual
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
23 States decennial census of 2020 for the State of Georgia; and

24 (2) Except as otherwise provided in the description of any district, whenever the
25 description of any district refers to a named city, it shall mean the geographical
26 boundaries of that city as shown on the census maps for the United States decennial
27 census of 2020 for the State of Georgia.

28 (d) Any part of the Monroe County School District which is not included in any district
29 described in subsection (b) of this section shall be included within that district contiguous
30 to such part which contains the least population according to the United States decennial
31 census of 2020 for the State of Georgia.

32 (e) Any part of the Monroe County School District which is described in subsection (b)
33 of this section as being included in a particular district shall nevertheless not be included
34 within such district if such part is not contiguous to such district. Such noncontiguous part
35 shall instead be included within that district contiguous to such part which contains the
36 least population according to the United States decennial census of 2020 for the State of
37 Georgia."

38 **SECTION 2.**

39 (a) Those members of the Board of Education of Monroe County who are serving as such
40 on the effective date of this Act and any person selected to fill a vacancy in any such office
41 shall continue to serve as such members until the regular expiration of their respective terms
42 of office and upon the election and qualification of their respective successors.

43 (b) Education Districts 1, 2, 3, 4, 5, 6, and 7, as they exist immediately prior to the effective
44 date of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, 5, 6, and 7,
45 respectively, but as newly described under this Act, and on and after the effective date of this
46 Act, such members of the board serving from those former districts shall be deemed to be
47 serving from and representing their respective districts as newly described under this Act.

48 **SECTION 3.**

49 The provisions of this Act necessary to conduct elections for the members of the Board of
50 Education of Monroe County in 2022 shall become effective upon the approval of this Act
51 by the Governor or upon its becoming law without such approval. The remaining provisions
52 of this Act shall become effective on January 1, 2023.

53 **SECTION 4.**

54 All laws and parts of laws in conflict with this Act are repealed.
