

House Bill 1229 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a board of commissioners of roads and revenues for the County
2 of Pike, approved October 31, 1870 (Ga. L. 1870, p. 447), as amended, particularly by an Act
3 approved February 26, 2014 (Ga. L. 2014, p. 3510), so as to change the description of the
4 commissioner districts; to provide for definitions and inclusions; to provide for the
5 continuation in office of current members; to provide for election and terms of office of
6 subsequent members; to provide for effective dates; to repeal conflicting laws; and for other
7 purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act creating a board of commissioners of roads and revenues for the County of Pike,
11 approved October 31, 1870 (Ga. L. 1870, p. 447), as amended, particularly by an Act
12 approved February 26, 2014 (Ga. L. 2014, p. 3510), is amended by revising subsection (d)
13 of Section 2 as follows:

14 "(d)(1) For purposes of electing members of the board of commissioners, other than the
15 chairperson, Pike County is divided into four commissioner districts. One member of the
16 board shall be elected from each district. The four commissioner districts shall be and

17 correspond to those four numbered districts described in Appendix A attached to and
18 made a part of this Act and further identified as 'User: Pike Plan Name: PikeCC-2022
19 Plan Type: Local'.

20 (2) For the purposes of such plan:

21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
22 provided in the report of the Bureau of the Census for the United States decennial
23 census of 2020 for the State of Georgia. The separate numeric designations in a district
24 description which are underneath a VTD heading shall mean and describe individual
25 Blocks within a VTD as provided in the report of the Bureau of the Census for the
26 United States decennial census of 2020 for the State of Georgia; and

27 (B) Except as otherwise provided in the description of any district, whenever the
28 description of any district refers to a named city, it shall mean the geographical
29 boundaries of that city as shown on the census maps for the United States decennial
30 census of 2020 for the State of Georgia.

31 (3) Any part of Pike County which is not included in any district described in
32 paragraph (1) of this subsection shall be included within that district contiguous to such
33 part which contains the least population according to the United States decennial census
34 of 2020 for the State of Georgia.

35 (4) Any part of Pike County which is described in paragraph (1) of this subsection as
36 being included in a particular district shall nevertheless not be included within such
37 district if such part is not contiguous to such district. Such noncontiguous part shall
38 instead be included within that district contiguous to such part which contains the least
39 population according to the United States decennial census of 2020 for the State of
40 Georgia."

41 **SECTION 2.**

42 (a) Those members of the board of commissioners of Pike County serving on the effective
43 date of this Act and any person selected to fill a vacancy in any such office shall continue to
44 serve as such members until the regular expiration of their respective terms of office and
45 upon the election and qualification of their respective successors.

46 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
47 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
48 respectively, but as newly described under this Act, and on and after the effective date of this
49 Act, such members of the board serving from those former commissioner districts shall be
50 deemed to be serving from and representing their respective districts as newly described
51 under this Act.

52 **SECTION 3.**

53 Said Act is further amended by striking in its entirety the attachment thereto containing the
54 descriptions of the four commissioner districts which is identified as 'Plan: pikeecc-2013 Plan
55 Type: Local Administrator: Pike User: Gina'.

56 **SECTION 4.**

57 The provisions of this Act necessary to conduct elections for the members of the board
58 in 2022 shall become effective upon the approval of this Act by the Governor or upon its
59 becoming law without such approval. The remaining provisions of this Act shall become
60 effective on January 1, 2023.

61 **SECTION 5.**

62 All laws and parts of laws in conflict with this Act are repealed.
