

House Bill 1245 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating the Board of Commissioners of Roads and Revenues in the
2 Counties of Floyd, Berrien, Effingham, Schley, Sumter, and Greene, approved December 13,
3 1871 (Ga. L. 1871, p. 225), as amended, particularly by an Act approved September 21, 2011
4 (Ga. L. 2011 Ex. Sess., p. 287), so as to change the description of the commissioner districts
5 of Sumter County; to provide for definitions and inclusions; to provide for continuation in
6 office of current members; to provide for effective dates; to provide for related matters; to
7 repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Roads and Revenues in the Counties of
11 Floyd, Berrien, Effingham, Schley, Sumter, and Greene, approved December 13, 1871 (Ga.
12 L. 1871, p. 225), as amended, particularly by an Act approved September 21, 2011 (Ga. L.
13 2011 Ex. Sess., p. 287), is amended by revising Section 1 as follows:

"SECTION 1.

(a) For purposes of electing members of the board of commissioners, Sumter County is divided into five commissioner districts. One member of the board shall be elected from each such district. The five commissioner districts shall be and correspond to those five numbered districts described in Appendix A attached to and made a part of this Act and further identified as 'User: Sumter CC Plan Name: SumterCC-2022 Plan Type: Local'.

(b)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in a district description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.

(2) Any part of Sumter County which is not included in any district described in subsection (a) of this section shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.

(3) Any part of Sumter County which is described in subsection (a) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

41 **SECTION 2.**

42 (a) Those members of the Board of Commissioners of Sumter County who are serving as
43 such on the effective date of this Act and any person selected to fill a vacancy in any such
44 office shall continue to serve as such members until the regular expiration of their respective
45 terms of office and upon the election and qualification of their respective successors.

46 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
47 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
48 respectively, but as newly described under this Act, and on and after the effective date of this
49 Act, such members of the board serving from those former commissioner districts shall be
50 deemed to be serving from and representing their respective districts as newly described
51 under this Act.

52 **SECTION 3.**

53 The provisions of this Act necessary to conduct elections for the members of the board
54 in 2022 shall become effective upon the approval of this Act by the Governor or upon its
55 becoming law without such approval. The remaining provisions of this Act shall become
56 effective on January 1, 2023.

57 **SECTION 4.**

58 All laws and parts of laws in conflict with this Act are repealed.
