

House Bill 1255 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the Board of Education of Schley County, approved March 4,  
2 1977 (Ga. L. 1977, p. 2955), as amended, so as to change the description of education  
3 districts; to provide for definitions and inclusions; to provide for continuation in office of  
4 current members; to provide for effective dates; to repeal conflicting laws; and for other  
5 purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the Board of Education of Schley County, approved March 4, 1977  
9 (Ga. L. 1977, p. 2955), as amended, is amended by revising subsection (a) of Section 1 as  
10 follows:

11 "(a)(1) For purposes of electing members of the board of education other than the  
12 at-large member, the Schley County School District is divided into four education  
13 districts. One member of the board shall be elected from each such district. The four  
14 education districts shall be and correspond to those four numbered districts described in  
15 Appendix A attached to and made a part of this Act and further identified as 'User: Schley  
16 Co. Plan Name: SchleyCCSB-2022 Plan Type: Local'. The fifth member of the board

17 shall be elected at large from the entire Schley County School District and such position  
18 shall be designated as Education District 5.

19 (2) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
21 provided in the report of the Bureau of the Census for the United States decennial  
22 census of 2020 for the State of Georgia. The separate numeric designations in a district  
23 description which are underneath a VTD heading shall mean and describe individual  
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
25 United States decennial census of 2020 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the  
27 description of any district refers to a named city, it shall mean the geographical  
28 boundaries of that city as shown on the census maps for the United States decennial  
29 census of 2020 for the State of Georgia.

30 (2) Any part of the Schley County School District which is not included in any district  
31 described in paragraph (1) of this subsection shall be included within that district  
32 contiguous to such part which contains the least population according to the United States  
33 decennial census of 2020 for the State of Georgia.

34 (3) Any part of the Schley County School District which is described in paragraph (1)  
35 of this subsection as being included in a particular district shall nevertheless not be  
36 included within such district if such part is not contiguous to such district. Such  
37 noncontiguous part shall instead be included within that district contiguous to such part  
38 which contains the least population according to the United States decennial census  
39 of 2020 for the State of Georgia."

## SECTION 2.

41 (a) Those members of the Board of Education of Schley County who are serving as such on  
42 the effective date of this Act and any person selected to fill a vacancy in any such office shall

43 continue to serve as such members until the regular expiration of their respective terms of  
44 office and upon the election and qualification of their respective successors.

45 (b) Education Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date  
46 of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, and 5,  
47 respectively, but as newly described under this Act, and on and after the effective date of this  
48 Act, such members of the board serving from those former education districts shall be  
49 deemed to be serving from and representing their respective districts as newly described  
50 under this Act.

51 **SECTION 3.**

52 The provisions of this Act necessary to conduct elections for the members of the Board of  
53 Education of Schley County in 2022 shall become effective upon the approval of this Act by  
54 the Governor or upon its becoming law without such approval. The remaining provisions  
55 of this Act shall become effective on January 1, 2023.

56 **SECTION 4.**

57 All laws and parts of laws in conflict with this Act are repealed.
