

House Bill 1268 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act reconstituting the Board of Education of Terrell County, approved  
2 April 13, 2004 (Ga. L. 2004, p. 3555), as amended, particularly by an Act approved February  
3 27, 2012 (Ga. L. 2012, p. 3729), so as to revise the districts for the election of members of  
4 the board of education; to provide for definitions and inclusions; to provide for continuation  
5 in office of current members; to provide for related matters; to provide for effective dates;  
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act reconstituting the Board of Education of Terrell County, approved April 13, 2004  
10 (Ga. L. 2004, p. 3555), as amended, particularly by an Act approved February 27, 2012 (Ga.  
11 L. 2012, p. 3729), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) The Board of Education of Terrell County shall consist of five members, all of whom  
14 shall be elected from the education districts described herein. For the purpose of electing  
15 members of the board of education, the Terrell County School District is divided into five

16 education districts. One member of the board shall be elected from each such district.  
17 Education Districts 1 through 5 shall be and correspond to those five numbered districts  
18 described in and attached to and made a part of this Act and further identified as 'User:  
19 Terrell Plan Name: TerrellSB-2022 Plan Type: Local'.

20 (b)(1) For the purposes of such plan:

21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
22 provided in the report of the Bureau of the Census for the United States decennial  
23 census of 2020 for the State of Georgia. The separate numeric designations in a district  
24 description which are underneath a VTD heading shall mean and describe individual  
25 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
26 United States decennial census of 2020 for the State of Georgia; and

27 (B) Except as otherwise provided in the description of any district, whenever the  
28 description of any district refers to a named city, it shall mean the geographical  
29 boundaries of that city as shown on the census map for the United States decennial  
30 census of 2020 for the State of Georgia.

31 (2) Any part of the Terrell County School District which is not included in any district  
32 described in subsection (a) of this section shall be included within that district contiguous  
33 to such part which contains the least population according to the United States decennial  
34 census of 2020 for the State of Georgia.

35 (3) Any part of the Terrell County School District which is described in subsection (a)  
36 of this section as being in a particular district shall nevertheless not be included within  
37 such district if such part is not contiguous to such district. Such noncontiguous part shall  
38 instead be included within that district contiguous to such part which contains the least  
39 population according to the United States decennial census of 2020 for the State of  
40 Georgia."

41 **SECTION 2.**

42 Said Act is further amended by repealing and reserving (b) of Section 4.

43 **SECTION 3.**

44 (a) Those members of the Board of Education of Terrell County who are serving as such on  
45 the effective date of this Act and any person selected to fill a vacancy in any such office shall  
46 continue to serve as such members until the regular expiration of their respective terms of  
47 office and upon the election and qualification of their respective successors.

48 (b) Education Districts 1 through 5, as they exist immediately prior to the effective date of  
49 this Act, shall continue to be designated as Education Districts 1 through 5, respectively, but  
50 as newly described under this Act, and on and after the effective date of this Act, such  
51 members of the board serving from those former districts shall be deemed to be serving from  
52 and representing their respective districts as newly described under this Act.

53 **SECTION 4.**

54 The provisions of this Act necessary to conduct elections for the members of the board in  
55 2022 shall become effective upon the approval of this Act by the Governor or upon its  
56 becoming law without such approval. The remaining provisions of this Act shall become  
57 effective January 1, 2023.

58 **SECTION 5.**

59 All laws and parts of laws in conflict with this Act are repealed.
