

House Bill 1287 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a board of commissioners of roads and revenues of Upson County,  
2 approved February 1, 1877 (Ga. L. 1877, p. 267), as amended, particularly by an Act  
3 approved February 27, 2012 (Ga. L. 2012, p. 3803), so as to change the description of the  
4 commissioner districts; to provide for definitions and inclusions; to provide for continuation  
5 in office of current members; to provide for related matters; to repeal conflicting laws; and  
6 for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating a board of commissioners of roads and revenues of Upson County, approved  
10 February 1, 1877 (Ga. L. 1877, p. 267), as amended, particularly by an Act approved  
11 February 27, 2012 (Ga. L. 2012, p. 3803), is amended by revising subsection (d) of Section 2  
12 as follows:

13 "(d)(1) For purposes of electing members of the board of commissioners, other than the  
14 chairperson, Upson County is divided into four commissioner districts. One member of  
15 the board shall be elected from each such district. The four commissioner districts shall  
16 be and correspond to those four numbered districts described in Appendix A attached to

17 and made a part of this Act and further identified as 'User: Upson CC Plan Name:  
18 UpsonCC-2022 Plan Type: Local'.

19 (2)(A) For the purposes of such plan:

20 For the purposes of such plan:

21 (i) The term 'VTD' shall mean and describe the same geographical boundaries as  
22 provided in the report of the Bureau of the Census for the United States decennial  
23 census of 2020 for the State of Georgia. The separate numeric designations in a  
24 district description which are underneath a VTD heading shall mean and describe  
25 individual Blocks within a VTD as provided in the report of the Bureau of the Census  
26 for the United States decennial census of 2020 for the State of Georgia; and

27 (ii) Except as otherwise provided in the description of any district, whenever the  
28 description of any district refers to a named city, it shall mean the geographical  
29 boundaries of that city as shown on the census maps for the United States decennial  
30 census of 2020 for the State of Georgia.

31 (B) Any part of Upson County which is not included in any district described in  
32 subsection (a) of this section shall be included within that district contiguous to such  
33 part which contains the least population according to the United States decennial census  
34 of 2020 for the State of Georgia.

35 (C) Any part of Upson County which is described in paragraph 1 of this subsection as  
36 being included in a particular district shall nevertheless not be included within such  
37 district if such part is not contiguous to such district. Such noncontiguous part shall  
38 instead be included within that district contiguous to such part which contains the least  
39 population according to the United States decennial census of 2020 for the State of  
40 Georgia."

41 **SECTION 2.**

42 Said Act is further amended by revising subsection (a) of Section 3 as follows:

43 "(a) Those members of the Board of Commissioners of Upson County who are serving as  
44 such on the effective date of this subsection and any person selected to fill a vacancy in any  
45 such office shall continue to serve as such members until the regular expiration of their  
46 respective terms of office and upon the election and qualification of their respective  
47 successors. On and after the effective date of this subsection, the Board of Commissioners  
48 of Upson County shall consist of five members, all of whom shall be elected from  
49 commissioner districts described in subsection (d) of Section 2, except for the member who  
50 is chairperson and who is elected at large as provided in subsection (a) of Section 1."

51 **SECTION 3.**

52 Said Act is further amended by revising paragraph (2) of subsection (b) of Section 3 as  
53 follows:

54 "(2) Commissioner Districts 1, 2, 3, and 4, as they exist on the effective date of this  
55 paragraph shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,  
56 respectively, but as newly described under subsection (d) of Section 2 of this Act, and on  
57 and after the effective date of this paragraph, such members of the board serving from  
58 those former commissioner districts shall be deemed to be serving from and representing  
59 their respective districts as newly described under subsection (d) of Section 2 of this Act."

60 **SECTION 4.**

61 All laws and parts of laws in conflict with this Act are repealed.
