

House Bill 947 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act reconstituting the Board of Education of Jasper County, approved April 5,
2 1993 (Ga. L. 1993, p. 4622), as amended, particularly by an Act approved February 12, 2012
3 (Ga. L. 2012, p. 3579), so as to change the description of the education districts for the board
4 of education; to provide for definitions and inclusions; to provide for the continuation in
5 office of current board members; to provide for related matters; to provide for effective dates;
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act reconstituting the Board of Education of Jasper County, approved April 5, 1993
10 (Ga. L. 1993, p. 4622), as amended, particularly by an Act approved February 12, 2012
11 (Ga. L. 2012, p. 3579), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) For the purpose of electing members of the board of education, the Jasper County
14 School District shall be divided into five education districts. Education Districts 1 through
15 5 shall be and correspond to those five numbered districts described in Appendix A

16 attached to and made a part of this Act and further identified as 'User: Jasper Co. Plan
17 Name: JasperCCSB-2022 Plan Type: Local'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a district
22 description which are underneath a VTD heading shall mean and describe individual
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (2) Any part of the Jasper County School District which is not included in any district
30 described in subsection (a) of this section shall be included within that district contiguous
31 to such part which contains the least population according to the United States decennial
32 census of 2020 for the State of Georgia.

33 (3) Any part of the Jasper County School District which is described in subsection (a)
34 of this section as being included in a particular district shall nevertheless not be included
35 within such district if such part is not contiguous to such district. Such noncontiguous
36 part shall instead be included within that district contiguous to such part which contains
37 the least population according to the United States decennial census of 2020 for the State
38 of Georgia."

39

SECTION 2.

40 (a) Those members of the Board of Education of Jasper County who are serving as such on
41 the effective date of this Act and any person selected to fill a vacancy in any such office shall

42 continue to serve as such members until the regular expiration of their respective terms of
43 office and upon the election and qualification of their respective successors.

44 (b) Education Districts 1 through 5, as they exist immediately prior to the effective date of
45 this Act, shall continue to be designated as Education Districts 1 through 5, respectively, but
46 as newly described under this Act, and on and after the effective date of this Act, such
47 members of the board serving from those former districts shall be deemed to be serving from
48 and representing their respective districts as newly described under this Act.

49 **SECTION 3.**

50 The provisions of this Act necessary to conduct elections for the members of the board in
51 2022 shall become effective upon the approval of this Act by the Governor or upon its
52 becoming law without such approval. The remaining provisions of this Act shall become
53 effective January 1, 2023.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
