A BILL TO BE ENTITLED

AN ACT

1 To amend an Act to provide for the election of the members of the Lumpkin County Board
2 of Education, approved April 12, 1982 (Ga. L. 1982, p. 4277), as amended, particularly by
3 an Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 336), so as to change the
4 description of the education districts; to provide for definitions and inclusions; to provide for
5 continuation in office of current members; to provide for related matters; to provide for
6 effective dates; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act to provide for the election of the members of the Lumpkin County Board of
10 Education, approved April 12, 1982 (Ga. L. 1982, p. 4277), as amended, particularly by an
11 Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 336), is amended by revising
12 subsections (a) and (b) of Section 2 as follows:

13 "(a) For purposes of electing the four members of the Lumpkin County Board of Education
14 who must be residents of education districts, the Lumpkin County School District shall be
15 divided into four education districts. Districts 1 through 4 shall be and correspond to those
16 four numbered districts described in Appendix A attached to and made a part of this Act

17 and further identified as 'User: Lumpkin Co. Plan Name: lumpkinccsb-2022 Plan Type: Local'.

18 (b) For the purposes of such plan:

19 (1)(A) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a district
22 description which are underneath a VTD heading shall mean and describe individual
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (2) Any part of the Lumpkin County School District which is not included in any district
30 described in subsection (a) of this section shall be included within that district contiguous
31 to such part which contains the least population according to the United States decennial
32 census of 2020 for the State of Georgia.

33 (3) Any part of the Lumpkin County School District which is described in subsection (a)
34 of this section as being included in a particular district shall nevertheless not be included
35 within such district if such part is not contiguous to such district. Such noncontiguous
36 part shall instead be included within that district contiguous to such part which contains
37 the least population according to the United States decennial census of 2020 for the State
38 of Georgia."

SECTION 2.

40 (a) Those members of the Lumpkin County Board of Education who are serving as such on
41 the effective date of this Act and any person selected to fill a vacancy in any such office shall

42 continue to serve as such members until the regular expiration of their respective terms of
43 office and upon the election and qualification of their respective successors.

44 (b) Districts 1 through 4, as they exist immediately prior to the effective date of this Act,
45 shall continue to be designated as Districts 1 through 4, respectively, but as newly described
46 under this Act, and on and after the effective date of this Act, such members of the board
47 serving from those former districts shall be deemed to be serving from and representing their
48 respective districts as newly described under this Act.

SECTION 3.

50 The provisions of this Act necessary to conduct elections for the members of the Lumpkin
51 County Board of Education in 2022 shall become effective upon the approval of this Act by
52 the Governor or upon its becoming law without such approval. The remaining provisions
53 of this Act shall become effective on January 1, 2023.

SECTION 4.

55 All laws and parts of laws in conflict with this Act are repealed.
