A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a multimember board of commissioners of Haralson County,
- 2 approved August 24, 2001 (Ga. L. 2001, Ex. Sess., p. 247), as amended, particularly by an
- 3 Act approved April 4, 2012 (Ga. L. 2012, p. 4648), so as to revise the districts for the
- 4 election of members of the board of commissioners; to provide for definitions and inclusions;
- 5 to provide for the continuation in office for the current members; to provide for related
- 6 matters; to provide for effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a multimember board of commissioners of Haralson County, approved
- 10 August 24, 2001 (Ga. L. 2001, Ex. Sess., p. 247), as amended, particularly by an Act
- 11 approved April 4, 2012 (Ga. L. 2012, p. 4648), is amended by revising subsections (b)
- 12 and (c) of Section 2 as follows:

- 13 "(b) Commissioner Districts 1 through 4 shall be and correspond to those four numbered
- 14 districts described in Appendix A attached to and made a part of this Act and further
- identified as 'User: Haralson Plan Name: HaralsonCC-2022 Plan Type: Local'.
- 16 (c)(1) For the purposes of such plan:

17 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 18 provided in the report of the Bureau of the Census for the United States decennial 19 census of 2020 for the State of Georgia. The separate numeric designations in a district 20 description which are underneath a VTD heading shall mean and describe individual 21 Blocks within a VTD as provided in the report of the Bureau of the Census for the 22 United States decennial census of 2020 for the State of Georgia; and 23 (B) Except as otherwise provided in the description of any district, whenever the 24 description of any district refers to a named city, it shall mean the geographical 25 boundaries of that city as shown on the census maps for the United States decennial 26 census of 2020 for the State of Georgia. 27 (2) Any part of Haralson County which is not included in any district described in 28 subsection (b) of this section shall be included within that district contiguous to such part 29 which contains the least population according to the United States decennial census of 30 2020 for the State of Georgia. 31 (3) Any part of Haralson County which is described in subsection (b) of this section as 32 being included in a particular district shall nevertheless not be included within such 33 district if such part is not contiguous to such district. Such noncontiguous part shall 34 instead be included within that district contiguous to such part which contains the least 35 population according to the United States decennial census of 2020 for the State of 36 Georgia."

37 SECTION 2.

38 (a) Those members of the Board of Commissioners of Haralson County who are serving as 39 such on the effective date of this Act and any person selected to fill a vacancy in any such 40 office shall continue to serve as such members until the regular expiration of their respective 41 terms of office and upon the election and qualification of their respective successors.

42 (b) Commissioner Districts 1 through 4, as they exist immediately prior to the effective date

- 43 of this Act, shall continue to be designated as Commissioner Districts 1 through 4,
- 44 respectively, but as newly described under this Act, and on and after the effective date of this
- 45 Act, such members of the board serving from those former commissioner districts shall be
- 46 deemed to be serving from and representing their respective districts as newly described
- 47 under this Act.

48 SECTION 3.

- 49 The provisions of this Act necessary to conduct elections for the members of the board in
- 50 2022 shall become effective upon the approval of this Act by the Governor or upon its
- 51 becoming law without such approval. The remaining provisions of this Act shall become
- 52 effective on January 1, 2023.

SECTION 4.

54 All laws and parts of laws in conflict with this Act are repealed.
