A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a Board of Commissioners of McDuffie County, approved
2 February 16, 1955 (Ga. L. 1955, p. 2331), as amended, particularly by an Act approved
3 February 6, 2012 (Ga. L. 2012, p. 3815), so as to change the description of the commissioner
4 districts; to provide for definitions and inclusions; to provide for continuation in office of
5 current members; to provide for related matters; to provide for effective dates; to repeal
6 conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating a Board of Commissioners of McDuffie County, approved February 16,
10 1955 (Ga. L. 1955, p. 2331), as amended, particularly by an Act approved February 6, 2012
11 (Ga. L. 2012, p. 3815), is amended by revising subsection (a) of Section 3 as follows:

12 "(a)(1) For the purpose of electing the members of the board, McDuffie County is hereby
13 divided into two commissioner districts. Districts 1 and 2 shall be and correspond to
14 those two numbered districts described in Appendix A attached to and made a part of this
15 Act and further identified as 'User: McDuffie CC Plan Name: McDuffieCC-2022
16 Plan Type: Local'.

17 (2)(A) For the purposes of such plan:

18 (i) The term 'VTD' shall mean and describe the same geographical boundaries as
19 provided in the report of the Bureau of the Census for the United States decennial
20 census of 2020 for the State of Georgia. The separate numeric designations in a
21 district description which are underneath a VTD heading shall mean and describe
22 individual Blocks within a VTD as provided in the report of the Bureau of the Census
23 for the United States decennial census of 2020 for the State of Georgia; and

24 (ii) Except as otherwise provided in the description of any district, whenever the
25 description of any district refers to a named city, it shall mean the geographical
26 boundaries of that city as shown on the census maps for the United States decennial
27 census of 2020 for the State of Georgia.

28 (B) Any part of McDuffie County which is not included in any district described in
29 paragraph (1) of this subsection shall be included within that district contiguous to such
30 part which contains the least population according to the United States decennial census
31 of 2020 for the State of Georgia.

32 (C) Any part of McDuffie County which is described in paragraph (1) of this
33 subsection as being included in a particular district shall nevertheless not be included
34 within such district if such part is not contiguous to such district. Such noncontiguous
35 part shall instead be included within that district contiguous to such part which contains
36 the least population according to the United States decennial census of 2020 for the
37 State of Georgia."

38 **SECTION 2.**

39 (a) Those members of the Board of Commissioners of McDuffie County who are serving
40 as such on the effective date of this Act and any person selected to fill a vacancy in any such
41 office shall continue to serve as such members until the regular expiration of their respective
42 terms of office and upon the election and qualification of their respective successors.

43 (b) Commissioner Districts 1 and 2, as they exist immediately prior to the effective date of
44 this Act, shall continue to be designated as Commissioner Districts 1 and 2, respectively, but
45 as newly described under this Act, and on and after the effective date of this Act, such
46 members of the board serving from those former commissioner districts shall be deemed to
47 be serving from and representing their respective districts as newly described under this Act.

48 **SECTION 3.**

49 The provisions of this Act necessary to conduct elections for the members of the Board of
50 Commissioners of McDuffie County in 2022 shall become effective upon the approval of this
51 Act by the Governor or upon its becoming law without such approval. The remaining
52 provisions of this Act shall become effective on January 1, 2023.

53 **SECTION 4.**

54 All laws and parts of laws in conflict with this Act are repealed.
