A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing for the consolidation of Richmond County and the City of
2 Augusta, approved March 27, 1995 (Ga. L. 1995, p. 3648), as amended, particularly by an
3 Act approved April 8, 2002 (Ga. L. 2002, p. 3769), so as to change the description of the
4 commission districts; to provide for definitions and inclusions; to provide for continuation
5 in office of current members; to provide for related matters; to provide for effective dates;
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the consolidation of Richmond County and the City of Augusta,
10 approved March 27, 1995 (Ga. L. 1995, p. 3648), as amended, particularly by an Act
11 approved April 8, 2002 (Ga. L. 2002, p. 3769), is amended by revising subsection (a) of
12 Section 2 as follows:

13 "(a)(1) For the purpose of electing members of the Augusta-Richmond County
14 Commission, Richmond County is divided into ten commission districts. One member
15 of the board shall be elected from each such district. Commission Districts 1, 2, 3, 4, 5,
16 6, 7, and 8 shall be and correspond to those eight numbered districts described in

17 Appendix A attached to and made a part of this Act and further identified as 'User: SD23
18 Plan Name: RichmondCCSB-Legis-2022 Plan Type: Local'. Commission Districts 9 and
19 10 shall be and correspond to those two numbered districts described in Appendix B
20 attached to and made a part of this Act and further identified as 'User: SD23 Plan Name:
21 RichmondCCSB-Legis-super-2022 Plan Type: Local'.

22 (2)(A) For the purposes of such plans:

23 (i) The term 'VTD' shall mean and describe the same geographical boundaries as
24 provided in the report of the Bureau of the Census for the United States decennial
25 census of 2020 for the State of Georgia. The separate numeric designations in a
26 district description which are underneath a VTD heading shall mean and describe
27 individual Blocks within a VTD as provided in the report of the Bureau of the Census
28 for the United States decennial census of 2020 for the State of Georgia; and

29 (ii) Except as otherwise provided in the description of any district, whenever the
30 description of any district refers to a named city, it shall mean the geographical
31 boundaries of that city as shown on the census maps for the United States decennial
32 census of 2020 for the State of Georgia.

33 (B)(i) Any part of Augusta, Georgia, which is not included in Commission Districts 1
34 through 8 described in paragraph (1) of this subsection shall be included within that
35 district contiguous to such part which contains the least population according to the
36 United States decennial census of 2020 for the State of Georgia.

37 (ii) Any part of Augusta, Georgia, which is not included in Commission Districts 9
38 and 10 described in paragraph (1) of this subsection shall be included within that
39 district contiguous to such part which contains the least population according to the
40 United States decennial census of 2020 for the State of Georgia.

41 (C)(i) Any part of Augusta, Georgia, which is described in paragraph (1) of this
42 subsection as being included in Commission District 1, 2, 3, 4, 5, 6, 7, or 8 shall
43 nevertheless not be included within such district if such part is not contiguous to such

44 district. Such noncontiguous part shall instead be included within that district
45 contiguous to such part which contains the least population according to the United
46 States decennial census of 2020 for the State of Georgia.

47 (ii) Any part of Augusta, Georgia, which is described in paragraph (1) of this
48 subsection as being included in Commission District 9 or 10 shall nevertheless not be
49 included within such district if such part is not contiguous to such district. Such
50 noncontiguous part shall instead be included within that district contiguous to such
51 part which contains the least population according to the United States decennial
52 census of 2020 for the State of Georgia."

SECTION 2.

54 (a) Those members of the Augusta-Richmond County Commission who are serving as such
55 on the effective date of this Act and any person selected to fill a vacancy in any such office
56 shall continue to serve as such members until the regular expiration of their respective terms
57 of office and upon the election and qualification of their respective successors.

58 (b) Commission Districts 1, 2, 3, 4, 5, 6, 7, 8, 9, and 10, as they exist immediately prior to
59 the effective date of this Act, shall continue to be designated as Commission Districts 1, 2,
60 3, 4, 5, 6, 7, 8, 9, and 10, respectively, but as newly described under this Act, and on and
61 after the effective date of this Act, such members of the board serving from those former
62 commission districts shall be deemed to be serving from and representing their respective
63 districts as newly described under this Act.

SECTION 3.

65 The provisions of this Act necessary to conduct elections for the members of the
66 Augusta-Richmond County Commission in 2022 shall become effective upon the approval
67 of this Act by the Governor or upon its becoming law without such approval. The remaining
68 provisions of this Act shall become effective on January 1, 2023.

SECTION 4.

70 All laws and parts of laws in conflict with this Act are repealed.
