A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a new charter for the City of Doraville, approved October 13, 1971
2 (Ga. L. 1971, Ex. Sess., p. 2154), as amended, so as to provide that certain councilmembers
3 are elected by districts; to revise city council districts; to provide definitions and inclusions;
4 to provide for initial terms of office; to provide for the continuance in office for current
5 members; to provide for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act creating a new charter for the City of Doraville, approved October 13, 1971 (Ga. L.
9 1971, Ex. Sess., p. 2154), as amended, is amended by revising Section 2.01 as follows:

10 "SECTION 2.01.

11 Establishment of city government.

12 The corporate governmental powers of the City of Doraville shall be vested in a city
13 council to be composed of a mayor and councilmembers as described in this charter. The
14 councilmembers shall represent the respective districts in which they reside. The mayor

15 and councilmembers shall exercise their powers in the manner prescribed by this charter,
16 the Constitution, and applicable laws of the State of Georgia, or if not so prescribed, then
17 in such manner as prescribed by the duly established ordinances of the City of Doraville."

SECTION 2.

19 Said Act is further amended by revising Section 5.08 as follows:

"SECTION 5.08

21

Election districts, election of mayor and councilmembers.

22

(a)(1) For the purpose of electing councilmembers, the City of Doraville shall be divided
23 into two council districts. Three councilmembers shall be elected from and reside in each
24 district. Candidates for the district posts must reside in the district which they seek to
25 represent. Except as otherwise provided in this Act, one councilmember from each
26 district shall be elected by a majority vote of the qualified electors of his or her respective
27 district voting at the elections of the city, and two councilmembers from each district
28 shall be elected by a majority vote of the qualified electors of the city at large voting in
29 the elections of the city. Districts 1 and 2 shall be and correspond to those two numbered
30 districts described in Appendix B attached to and made a part of this Act and further
31 identified as 'User: Doraville Plan Name: DoravilleCC-2022 Plan Type: Local'.

(2) For the purposes of such plan:

33

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
34 provided in the report of the Bureau of the Census for the United States decennial
35 census of 2020 for the State of Georgia. The separate numeric designations in a district
36 description which are underneath a VTD heading shall mean and describe individual
37 Blocks within a VTD as provided in the report of the Bureau of the Census for the
38 United States decennial census of 2020 for the State of Georgia; and

39 (B) Except as otherwise provided in the description of any district, whenever the
40 description of any district refers to a named city, it shall mean the geographical
41 boundaries of that city as shown on the census maps for the United States decennial
42 census of 2020 for the State of Georgia.

43 (3) Any part of the City of Doraville which is not included in any district described in
44 paragraph (1) of this subsection shall be included within that district contiguous to such
45 part which contains the least population according to the United States decennial census
46 of 2020 for the State of Georgia.

47 (4) Any part of the City of Doraville which is described in paragraph (1) of this
48 subsection as being included in a particular district shall nevertheless not be included
49 within such district if such part is not contiguous to such district. Such noncontiguous
50 part shall instead be included within that district contiguous to such part which contains
51 the least population according to the United States decennial census of 2020 for the State
52 of Georgia.

53 (5) Any territory purportedly described as being in a district in paragraph (1) of this
54 subsection that is not within the corporate limits of the City of Doraville shall not be part
55 of any such district.

56 (b)(1) The council district seat for District 1, as it exists immediately prior to the
57 effective date of this Act, with a term of office expiring December 31, 2025, shall be
58 designated as Post 1 of District 1 but as newly described under this Act, and on and after
59 the effective date of this Act, such councilmember serving from that district shall be
60 deemed to be serving from and representing his or her respective district as newly
61 described under this Act;

62 (2) The council district seat for District 1, as it exists immediately prior to the effective
63 date of this Act, with a term of office expiring December 31, 2023, shall be designated
64 as Post 2 of District 1 but as newly described under this Act, and on and after the
65 effective date of this Act, such councilmember serving from that district shall be deemed

66 to be serving from and representing his or her respective district as newly described under
67 this Act;

68 (3) The council district seat for District 2, as it exists immediately prior to the effective
69 date of this Act, with a term of office expiring December 31, 2023, shall be designated
70 as Post 3 of District 1 but as newly described under this Act, and on and after the effective
71 date of this Act, such councilmember serving from that district shall be deemed to be
72 serving from and representing his or her respective district as newly described under this
73 Act;

74 (4) The council district seat for District 3, as it exists immediately prior to the effective
75 date of this Act, with a term of office expiring December 31, 2025, shall be designated
76 as Post 1 of District 2 but as newly described under this Act, and on and after the
77 effective date of this Act, such councilmember serving from that district shall be deemed
78 to be serving from and representing his or her respective district as newly described under
79 this Act;

80 (5) The council district seat for District 3, as it exists immediately prior to the effective
81 date of this Act, with a term of office expiring December 31, 2023, shall be designated
82 as Post 2 of District 2 but as newly described under this Act, and on and after the
83 effective date of this Act, such councilmember serving from that district shall be deemed
84 to be serving from and representing his or her respective district as newly described under
85 this Act; and

86 (6) The council district seat for District 2, as it exists immediately prior to the effective
87 date of this Act, with a term of office expiring December 31, 2025, shall be designated
88 as Post 3 of District 2 but as newly described under this Act, and on and after the
89 effective date of this Act, such councilmember serving from that district shall be deemed
90 to be serving from and representing his or her respective district as newly described under
91 this Act.

92 (c) Except as provided for in subsection (d) of this section:

- 93 (1) The mayor shall be elected to four-year terms of office by a majority of the qualified
94 electors of the city;
- 95 (2) All councilmembers shall be elected to four-year terms of office;
- 96 (3) The councilmembers elected from Posts 1 and 2 of Districts 1 and 2 shall be elected
97 by majority vote of the qualified electors of the city voting at large; and
- 98 (4) The councilmembers elected from Post 3 of Districts 1 and 2 shall be elected by
99 majority vote of the qualified electors of their respective district.
- 100 (d)(1) At the general municipal election held in 2023, the mayor, the councilmember for
101 Post 2 of District 1, and the councilmember for Post 2 of District 2 shall be elected to an
102 initial term of office of four years by a majority of the qualified electors of the city voting
103 at large.
- 104 (2) At the general municipal election held in 2023, the councilmember for Post 3 of
105 District 1 shall be elected to an initial term of office of two years by a majority of the
106 qualified electors of the city voting at large.
- 107 (3) At the general municipal election held in 2025, the councilmember for Post 1 of
108 District 1 and the councilmember for Post 1 of District 2 shall be elected to an initial term
109 of office of four years by a majority of the qualified electors of the city voting at large.
- 110 (4) At the general municipal election held in 2025, the councilmember for Post 3 of
111 District 1 and the councilmember for Post 3 of District 2 shall be elected to an initial term
112 of office of four years by majority vote of the qualified electors of their respective
113 district."

SECTION 3.

115 Those members of the City of Doraville City Council who are serving as such on the
116 effective date of this Act, and any person selected to fill a vacancy in any such office shall

117 continue to serve as such members until the regular expiration of their respective terms of
118 office and upon the election and qualification of their respective successors.

SECTION 4.

120 All laws and parts of laws in conflict with this Act are repealed.
