



# THE STATE OF GEORGIA

## EXECUTIVE ORDER

---

BY THE GOVERNOR:

**WHEREAS:** The State of Georgia and local governments entered into the Memorandum of Understanding Concerning National Distributor and Johnson & Johnson Opioid Settlements (the "MOU"); and

**WHEREAS:** The MOU provides for the establishment of a Government Participation Mechanism ("GPM") that shall consult with, and provide recommendations to, the Trustee of the Georgia Opioid Crisis Abatement Trust regarding the allocation of funds received by the State pursuant to National Distributor and Johnson & Johnson opioid settlements; and

**WHEREAS:** Pursuant to the MOU, a GPM shall be established as described in the Notice of Filing of Eighth Plan Supplement Pursuant to the Fifth Amended Joint Chapter 11 Plan of Reorganization of Purdue Pharma L.P. and its Affiliated Debtors, In re: Purdue Pharma L.P., et al, Case No. 19-23649-RDD, Dkt. 3121 (Bankr. S.D.N.Y. July 8, 2021), Exhibit G at 11 (the "Purdue Bankruptcy Plan"); and

**WHEREAS:** The Purdue Bankruptcy Plan provides that the State and the State's local governments shall have equal representation on the GPM and the State shall appoint a non-voting chairperson to the GPM.

**WHEREAS:** Pursuant to the MOU, each member of the GPM and the non-voting chairperson shall be appointed for a term of three years.

**NOW, THEREFORE, IN ACCORDANCE WITH THE MEMORANDUM OF UNDERSTANDING CONCERNING NATIONAL DISTRIBUTOR AND JOHNSON & JOHNSON OPIOID SETTLEMENTS AND PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY**

**ORDERED:** That the aforementioned GPM is hereby established as the Georgia Opioid Settlement Advisory Commission ("GOSAC").

**IT IS FURTHER**

**ORDERED:** That GOSAC shall be comprised of eight members and one non-voting chairperson.

**IT IS FURTHER**

**ORDERED:** That the following four persons are appointed to serve as the State's representatives on GOSAC, each for a term of office expiring May 18, 2026.


**IT IS FURTHER**

**ORDERED:** That the Honorable David Dove is appointed to serve as the chairperson of GOSAC, for a term of office expiring May 18, 2026.

**IT IS FURTHER**

**ORDERED:** That the State's local governments are requested to appoint four representatives to GOSAC, including one representative who is appointed by the Georgia Association of Community Service Boards as required by the MOU, and notify the chairperson of such appointments.
